News on Sustainable Development Governance from European Countries

Belgium:

Inspirational guide on SDG monitoring and reporting for local governments

The Association of Flemish Cities and Municipalities (VVSG) recently developed an inspirational guide on SDG monitoring and reporting for local governments. The guide is based on discussions with a working group of Flemish municipalities and on international experiences. The guide provides information on the added value of SDG monitoring and reporting, on how to effectively integrate SDG monitoring and reporting throughout the local policy cycle, how to determine SDG indicators and targets, and useful data sources. Although the primary target audience are Flemish municipalities, the guide contains a lot of useful information and ideas for local governments worldwide.

Hungary:

Newly elected Hungarian government reorganised the responsibilities of sustainability issues

The newly formed Ministry of Technology and Industry's [TIM] Minister prepares the government's sustainable development strategy and coordinates the implementation of government strategies for sustainable development, as well. Also, the Minister represents the Hungarian Government in international organizations for sustainable development.

According to the government decree 182/2022 (V.24.) about the (new) government's responsibilities, the newly formed Ministry of Technology and Industry [TIM] is responsible for (among others):

- energy policy;
- environmental protection;
- the transition to a circular economy and product value chain management; and
- the coordination of sustainable development tasks in the circular economy and waste management.

On 10 May 2022, the new President of Hungary was also elected. Mrs. Katalin Novak's focus areas are on family friendly values and young talents. With the launch of the new President's office, the office of the President of the Republic has been restructured and the former independent Environmental Sustainability Directorate is no longer in place.

Netherlands:

Preparing a second Voluntary National Review for the High Level Political Forum

The Kingdom of the Netherlands presented its second Voluntary National Review (VNR) in July this year during the yearly United Nations High Level Political Forum (HLPF) about the SDGs. The VNR has been produced through close cooperation of the four countries belonging to the Kingdom of the Netherlands. The report will have a joint introduction followed by four separate chapters of each country illustrating the progress and ambitions of the Kingdom of the Netherlands regarding the SDGs since the presentation of the first VNR in 2017. For the data of the Netherlands, six dialogues with stakeholders were held, in which different SDGs were discussed. These dialogues were based on the six transitions as formulated by the UN Global Sustainable Development Report from 2019.

Switzerland:

Adoption of the new Swiss VNR and the new web portal

Switzerland is well positioned to implement the 2030 Agenda. It is highly competitive and can rely on high-quality education and healthcare systems and well developed infrastructure. Since its last country report four years ago, there have been positive developments, including the achievement of marriage equality and an increase in the percentage of women in the Federal Assembly and in cantonal parliaments.

Despite this progress, Switzerland's domestic and foreign policies are not well enough aligned to the SDGs. To achieve all the goals by 2030, significant action and coordination are needed, particularly in the areas that the Federal Council has identified as priority themes in its Sustainable Development Strategy 2030 (SDS 2030): sustainable consumption and production, climate, energy and biodiversity, and equal opportunities and social cohesion.

The focus for Switzerland is on challenges such as reducing resource and energy consumption (high in this country per person in international and European comparison), reducing greenhouse gas emissions, preserving biodiversity, and expanding renewable energy. In addition, Switzerland strives to ensure equal opportunities for all and to promote each individual's empowerment. It has set itself the goal of achieving de facto gender equality. Civil society, the private and financial sectors, educators, researchers and innovators, joined by the cantons and communes, can contribute substantially to implementing measures aimed at achieving the goals.

In addition to the country report, the new <u>SDGital2030.ch website</u> details the current status of Switzerland's implementation of the 2030 Agenda. From 4 May 2022, assessments of each of the 17 Sustainable Development Goals and 169 targets will also be published there. These assessments are the result of the stocktaking survey that

involved not only the federal government, the cantons and the communes, but also numerous actors from the private sector, the scientific community and civil society who are committed to sustainable development. They were invited to submit their assessments of Switzerland's achievement of the goals during the 2018-22 survey period and to highlight their own contributions to the global sustainability goals.

Switzerland's comprehensive digitalisation of the 2030 Agenda process was ground breaking. The new solution makes it possible to bundle the entire stocktaking work, from data collection to consultation, translation and publication, into a single, seamless process. This has created a sustainable, transparent and structured database that can be maintained and continuously updated until 2030 and beyond.

Eurostat

Eurostat SDG Monitoring Report 2022 was published in May 2022

Monitoring is an essential component in realising the 2030 Agenda's vision, both globally and in the EU, by assessing and visualising the progress made so far towards the 17 SDGs. Since 2017, Eurostat has been preparing annual reports monitoring the progress towards the SDGs in the EU context. The 2022 edition of Eurostat's SDG monitoring report is the sixth report in this series, analysing the EU's progress towards the goals based on the official EU SDG indicator set.

Over the most recent five-year period of available data, the EU achieved the strongest progress towards fostering peace and personal security within its territory and improving access to justice and trust in institutions (SDG 16). Significant progress was also visible for the goals on reducing poverty and social exclusion (SDG 1), on the economy and the labour market (SDG 8), on clean and affordable energy (SDG 7) and on innovation and infrastructure (SDG 9). It is important to note that in the area of poverty (SDG 1), available data partly refer to the period up to 2019 only and therefore do not yet fully take into account the pandemic's impacts. In contrast, the favourable assessment of SDG 7 is strongly influenced by a remarkable reduction in energy consumption in 2020 as a result of COVID-19 related restrictions on public life and lower economic activity. The EU has also achieved good progress towards the goals on health and well-being (SDG 3), life below water (SDG 14) and gender equality (SDG 5). Progress towards the remaining goals was markedly slower, with few goals even experiencing slightly unsustainable overall trends over the most recent five-year period of available data.

EEAC Annual Conference

"The Critical Decade of Action: Mobilising Sustainability Transformation in Europe" 14-15 September 2022 in Helsinki

This year, the Annual Conference of the <u>EEAC Network</u> – entitled: "*The Critical Decade of Action: Mobilising Sustainability Transformation in Europe*" will take place in Helsinki on September 14th and 15th 2022 and will be hosted by Finland's three independent science panels, the Finnish Expert Panel for Sustainable Development, the Finnish Climate Change Panel and the Finnish Nature Panel.

The two-day conference brings together experts, particularly from academia and government, to discuss the next steps for facilitating the much-needed transformation in the critical decade of action. The conference will hear interesting keynote speeches and engage in sessions, including on the following themes:

- Medium-term actions needed against the biodiversity crisis;
- Joining forces for sustainability transformation; and
- Europe's global responsibility in climate change.
