Coordination of the SDGs implementation



HISTORY

Founded in 2002

as an advisory body of the Government of Montenegro for implementation of the sustainable development policy.

2006-2021. underwent several reforms

which, inter alia, included possibilities of establishing the expert working groups.

President and 39 members

All ministers in the Government, the Parliament secretary, professional institutions, financial institutions, business associations, universities, the Academy of Sciences, trade unions, NGOs, independent experts, youth and the media.

Presided by the President or the Prime Minister

The President of the National Council is the President of the Government or the State, and the Secretary of the National Council is the head of the Office for Sustainable Development.



IMPORTANCE & POWER



Broad consultative process



The largest forum for the mobilization of all interested actors, exchange of opinions and participatory decision-making on development issues through consensus.

Undisputed legitimacy of decisions



The Council's decisions cannot be challenged because they have been verified by all interested parties. In addition, the decisions were verified through the reports of the Council verified by adopting the conclusions at the Government sessions.

Harmonization of sustainable development policies



Harmonizes sectoral, strategic, planning and program documents and regulations with the Sustainable Development Goals and promotes dialogue and partnership building for development.



Reporting on country's behalf



National reporting to UN





Two National Voluntary Reports on the implementation of the Sustainable Development policy - in 2016 and 2021. The Office for Sustainable Development coordinates the preparation of the Report. According to the SDG Index, Montenegro advanced by 15 positions, from 86th to 67th place.

Monitoring the National SD Strategy



These reports provide an overview of the implementation of the National Sustainable Development Strategy until 2030 (NSDS), and thus the implementation of the Sustainable Development Goals in Montenegro. Reporting on the implementation of NSds 2030 has been done continuously since 2016.

Reaching a consensus on the 2030 Agenda



Montenegro, as one of the 32 UN members, prepared in 2023 a Statement on the country's commitment to meeting the SDGs. The statement resulted from broad national consultations and an expression of social consensus and the country's commitment to the 2030 Agenda.

Data collection importance and methods




Relevant data are key to achieving the Sustainable Development Goals because they provide a basis for informed decision-making, monitoring progress, and identifying priorities.

EU dimension



When the EU Commission assesses country's progress, it takes into account various aspects, including reforms, legal harmonization, economic development, social cohesion, fight against corruption, climate change and environmental protection.





MAPS Conclusions

Analysis of interlinkages between the EU accession process and Agenda 2030

- **strong synergy** between the EU accession process and the realization of the 2030 Agenda and the Sustainable Development Goals
- **two thirds** of SDG targets [109 out of 169 i.e. 65%] have a strong connection with EU Acquis chapters














SDGs integrated into EU policies



- EU played an active role in shaping the Agenda 2030.
- Agenda 2030 fully aligned with the values and goals of EU policies.
- In 2019, a document was adopted for consideration "Towards a Sustainable Europe by 2030" as part of the reflection process on the future of Europe.
- The EU puts the SDGs at the core of EU policy, legislation and funding "Achieving the Sustainable Development Goals A comprehensive approach".
- "Green Deal" nationally confirmed through the signing of the Sofia Declaration for the Western Balkans, through the green agenda for the WB.

CURRENT INITIATIVES



System of coordination of strategic partners



Improvement of cooperation between interested parties, which will result in more efficient implementation and monitoring of reforms, increased possibilities of financing development projects.

This mechanism will be located in the Office for Sustainable Development in Gov't General Secretariate.

Launching and maintenance of the Information System for Monitoring and Reporting - ISMR



The goal is to make work more efficient and planning processes more predictable. It provides a comprehensive overview of strategic documents, operational goals, current activities within the goals, performance indicators (KPI), responsible persons, connection with the budgeting module.

NEXT STEPS





- Focus on the organization of the 37th session of the National Council for Sustainable Development in accordance with the "Summit of the Future" theme, at UNHQ in September.
- Strengthening the capacity of the Office for Sustainable Development, in accordance with the recommendations of the National Council for SD and the State Audit Institution.
- Harmonization of legal acts which regulate the system of strategic planning and the creation of a special normative act [based on the comparative practices of EU members].
- Implementation of projects financed from the Montenegro SDG Acceleration Fund, as well as prioritization of ideas for potential financing from this Fund.
- Drafting of the Action Plan and responsibilities of all relevant actors for the implementation of the 'Declaration of commitment to the implementation of the SDGs'.
- Introduction of classification and budget targeting with SDGs Financing for sustainable development in cooperation with UNDP and the Ministry of Finance.



NEXT STEPS





- Development of the Communication Strategy for Sustainable Development, to support the implementation of the National Strategy for Sustainable Development.
- Signing of the Memorandum on Cooperation with the United Arab Emirates Government, which includes cooperation on the Program for the Exchange of Experiences.
- Involvement of interested parties in the implementation of SD the policies, primarely academic community, the economic sector, young people and citizens.
- Development and improvement of project proposals for potential financing from domestic and international funds and available financial resources.
- Publication of the Report on the work of the Office for Sustainable Development for 2022/23, which will be submitted and presented to the Parliament of Montenegro.
